THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976;

No.GH/V/75 of 2012/TPS-1406-2602-L: WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/101 of 1998/TPS-1496-3657-L, dated.22.07.1998 the Government of Gujarat, in exercise of the powers conferred by section 48(2) of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") sanctioned the Draft Town Planning Scheme No.25 (Tunki) (hereinafter referred to as "the said Draft Scheme") submitted by the Surat Municipal Corporation (hereinafter referred to as " the said Authority")

AND WHEREAS, in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for the finalizing the said Draft Scheme;

AND WHEREAS, the Town Planning Officer has submitted, to the Government of Gujarat, the Preliminary Town Planning Scheme No.25 (Tunki) (hereinafter referred to as "the said Preliminary Scheme") as required under section 52(2) and section 64 of the said Act.

NOW THEREFORE, in exercise of the powers conferred by section-65 of the said Act, the Government of Gujarat hereby:-

- Sanction the said Preliminary Scheme with modifications enumerated in schedule appended here to;
- State that the said preliminary scheme shall be kept open for the inspection of the public, at the office of the said Authority, during office hours on working days;
- Fix the date of this notification as the date for the purpose of clause (b) of sub-section (2) of the section 65.

## SCHEDULE

1. Boundary and area of final plot no. 118 (recreational) & 119 is modified as shown in accompanying plan.
2. The allotment of final plot no. 21 allotted is modified and is hereby allotted for the purpose of "School" as shown in accompanying plan.
3. Boundary and area of final plot no. 25 & 26 (Utility Centre) is modified as shown in accompanying plan.
4. As shown in accompanying plan, the allotment of final plot no. 99 for the purpose of "Utility Centre" is deleted and the original plot no. 64 is modified as 64/1 & 64/2 and in lieu of these original plots the allotment is as shown in the following table:

5. Boundary and area of final plot no. 97 for the purpose of "Housing for SEWS" is modified as shown in accompanying plan.
6. Boundary and area of final plot no.35 (District Centre) & 36 is modified.
7. For the Case no. 72/B +73 +74 +75 +76 +77 +78 +79 +80 +81 +82 +83/A the following note is added in the remark column of redistribution statement.  
"As the land of original plot nos. 69/A/P, 70 to 79, 80/A, 80/B, 69/B, 68/A/P is falling in no-construction zone, so no construction can be carried out in allotted final plot No. 106 in lieu of these original plots"
8. For the Case no. 22 the following note is added in the remark column of redistribution statement.  
"2. Above remark is only applicable to final plot no.51"
9. In consultation with Appropriate Authority and the Irrigation Department decide the boundary of embankment/retaining wall or the river line and thereafter for the land on the river side of the embankment/retaining wall/river line, as a principle for such land separate original plots have to be assigned and reconstituted in a manner the final plot is same as original plot. Also for all such final plots not to levy any incremental contribution. For such land the appropriate authority shall vary the scheme under section 71, till than

the appropriate authority shall not permit any development. The collector shall not grant N.A. permission for all such land until decision is taken for the varied scheme.

10. Any remarks in the scheme book or any notation relating to reservation under Development Plan of SUDA shall stand null & void

Preliminary Scheme document, maps, redistribution statement shall be modified according to above.

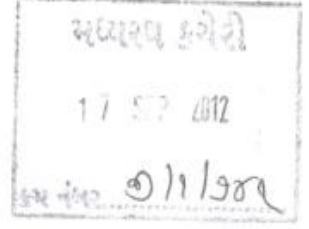

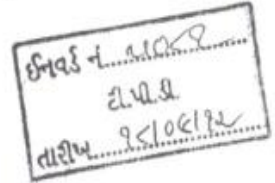
